CURRENT AFFAIRS


The Value Added Tax and Supplementary Duty Act, 2012 and Value Added Tax and Supplementary Rules, 2016 have come into effect from 1st July, 2019. These laws have brought significant changes in the regime of Value Added Tax (VAT) and supplementary duties.

Bangladesh and Japan have signed their 40th Official Development Assisstance (ODA) deal involving \$2.5 billion to implement 4 projects that include Matarbary Port Development Project, Dhaka Mass Rapid Transit Development Project, Foreign Direct Investment Project, Project and Energy Efficiency Promotion Project and Energy Efficiency and Conservation Promotion Financing Project.
