

E EDITORIAL

As a part of our continuing effort to disseminate important legal information, we are pleased to publish the eighth issue of the quarterly 'Legal Counsel News Bulletin' with some important updates.

DO YOU KNOW

- · As per article 87(1) of the Constitution of Bangladesh, it is the responsibility of the government to place before the Parliament an Annual Financial Statement with the estimated receipts and expenditure of the Government for each financial year, popularly known as the national budget. The statement is placed as the Finance Bill and once it is passed in the Parliament, the same is called the Finance Act. Upon achieving independence in the year 1971, the first budget of Bangladesh was presented by Mr. Tajuddin Ahmad in 1972 for an amount of Taka 786 Crore. The latest budget presented by the incumbent Finance Minister, Mr. AHM Mustaf Kamal is the 50th national budget and is valued at Taka 6,03,681 Crore. In 50 years, the volume of the budget has increased by 768 times.
- Bangladesh has received its second recommendation from the United Nations for graduating from a Least Developed Country (LDC) to a developing country.

CURRENT AFFAIRS

Over the past year, the GDP per capita of Bangladesh has grown by 9%, rising to \$2,227. Meanwhile, Pakistan and India's per capita income is \$1,543 and \$1,947 respectively. Eventually, Bangladesh is now 45% richer than Pakistan whereas in 1971, Pakistan (West Pakistan) was 70% richer than us (East Pakistan).

RISE OF DIGITALILZATION

'Digital Bangladesh' has been one of the most desired and long cherished dreams, being a crucial electoral pledge of the incumbent Government of Bangladesh. To realize its 'Vision 2021' and with the aim of emphasizing digital technology by maximizing its use, the Government has implemented numerous projects relating to digital technology in the recent past. In general, however, the working process in Bangladesh were heavily manual and was primarily reliant on human interventions. Nonetheless, after lockdown measures were imposed by the government due to the outbreak of COVID-19 in March 2020 and with the second wave hit on March 2021, all the economic activities of the country came to an abrupt halt twice. Following that and having no other alternatives, most offices declared that its employees shall be working from home (WFH). These offices resorted to continuing its operations through the aid of digital resources from home and accessibility of internet in commercial and residential areas have further aided the same.

Digitalization has not only flourished with regard to remote working for entities only. Even judicial proceedings have also been conducted through virtual courts. In terms of education, distance learning methods have been adopted by various educational institutions, which were mostly private, with the view to facilitating the continuity of the process of learning and education. Launching and use of telehealth services have also been witnessed and additional tools have further been developed to raise awareness and promote the use of telehealth. E-commerce has also flourished, thereby improving peoples' way and standard of living. Various online platforms such as Chaldal, Foodpanda, Pathao, Daraz, etc. have supported the buying goods for daily use as well as sophisticated goods, electronic appliances, etc. Making payments have further been easy through the contactless, trouble-free use of popular mobile financial services applications, such as Bkash, Nagad etc. However, such massive transformations did come along with various challenges, such as poor bandwidth, lack of sufficient laws regarding rapidly changing and ever growing IT based businesses, lack of guidelines for online teachings, lack of sufficient data infrastructures, skilled labour for telemedicine, etc. Moreover, unlike the white collar job holders who have had the privilege to use technology and work from home, factory/blue-collar workers had to be physically present at their workplaces.

It is, nevertheless, noteworthy to mention that Bangladesh, having embarked upon the journey of digitalization, have formulated improved and feasible working practices. It further gave a new dimension to the way of living, education, medical services, etc. for its people as well as facilitated for e-commerce to develop further. It is aspired that in the coming future, the country will come out stronger, with more resources, laws, policies, etc., to overcome its hindrances, accomplish its long-nurtured goals and visions of digitalization and will create examples for other countries in the world.
