The Evolution of Laws of Bangladesh over its 50 Years of Independence

Bangladesh marked 50 years of its independence in the year 2021. The golden jubilee of independence is the biggest milestone for the nation to celebrate. During this period of 50 years of independence, the legal system of Bangladesh has seen significant positive changes in the enactment and adaptation in the laws of Bangladesh. At present, Bangladesh is enriched with a number of pieces of legislations that are unique to the country, with no neighbouring countries having laws made on such matters, ensuring better rights to its citizens. The rich series of laws also include the legislations enacted prior to the independence in 1971, and also during the British Rule prior to 1947, such as The Contract Act, 1872, the Penal Code,1860, Code of Civil Procedure, 1908 etc. The Contract Act, 1872, for instance, was first enacted in the 19th century for the Indian sub-continent, and the Government of Bangladesh adopted it after independence and from time to time, has taken steps to adapt the law in the context of Bangladesh in order meet the requirements of the new country. Interestingly, although British initiated making of this piece of legislation for this sub-continent, United Kingdom still does not have a single legislation on Contract laws. Similarly, The Penal Code, 1860, which was made for this sub-continent, which Bangladesh adopted after independence and has been amending from time to time, most recently being in the year 2004. The other countries use the same Penal Code with necessary amendments to suit their country's requirement

After independence, Bangladesh has seen a massive development in the arena of laws. Over the years, the Government of Bangladesh enacted many specialized laws in order to protect vulnerable and special communities, persons or matters, a great examples being the Prevention of Women and Child Repression Act 2000 and The Children Act 2013. The Prevention of Women and Child Repression Act was introduced with great expectations to reduce and remove the violence against women as well as children and the Government has successfully and significantly minimized the rate of violence against women as well as children ever since. Similarly, the introduction of the Artha Rin Adalat Ain, 2003 brought changes to a great extent in the administration of justice delivery system for regulating suits for the recovery of money by financial institutions. It is pertinent to mention that there are separate tribunals for cases filed under Prevention of Women and Child Repression Act 2000 and Artha Rin Adalat Ain, 2003 in order to expedite trials. Besides, for the purpose of ensuring that mothers and families receive accurate and unbiased information about the healthiest way to feed their infants and young children-free of commercial influence, there is a law named The Bangladesh Breastmilk Substitutes, Infant Foods, Commercially Manufactured Complementary Foods, and the Accessories Thereof (Regulation of Marketing) Act (the Bangladesh BMS Act)2013, and there are additional bylaws of 2017, which cannot be found in other countries across the world. In addition, Bangladesh passes Finance Act every year which contains multiple provisions as to taxes, duties, exemption as well as reliefs and every year after the national budget is formed the provisions of the Finance Act are amended accordingly. Even, The Parents Care Act 2013 obligates the children to take good of their parents which includes providing food as well as shelter to their parents if they live with them or to provide 10% of their income if they do not live with them. With a view to eradicate the consumption of illegal drugs The Narcotics Control Act 1990 was introduced that regulates narcotics including production, distribution, transaction, possession, transportation, cultivation, etc.

Amongst others, The International Crimes (Tribunals) Act, 1973 (as amended) which is a domestic war crimes tribunal in Bangladesh was set up to investigate and prosecute suspects for the genocide committed in 1971 by the Pakistan Army and their local collaborators during the Bangladesh Liberation War. Bangladesh has a history of producing huge and affordable workforce. In many jurisdictions the matters regarding employment are dispersed into different laws as oppose to a single law like Bangladesh. The Bangladesh Labour Act 2006 ("Act") as well as the Bangladesh Labour Rules, 2015 ("Rules") codify all matters associated with labour and workforce in one place. The comprehensive nature of the law can immediately be gleaned from its coverage such as conditions of service and employment, youth employment, maternity benefit, health hygiene, safety, working hours and leave, wages and payment, workers' compensation for injury, trade unions and industrial relations and disputes, workers' participation in companies profits, provident funds, etc. The Act also established separate labour courts and labour appellate tribunals to deliver fast-tracked trials, to promote industrial peace and to establish a harmonious and cordial relationship between labour and capital by means of conciliation, mediation and adjudication.

The emergence of digitalization around the globe necessitated the institution of new cyber laws as the provisions of Penal Code, 1860 fell short to deal with crimes related to cyber matters. As a consequence, the Government took a radical approach and firstly established the Information and Communication Technology Act (ICT) of 2006 famously known as ICT Act 2006 to prevent cybercrimes and regulate e-commerce. Thereafter, the Digital Security Act, 2018 was passed with the aim of preventing the spread of racism; sectarianism; extremism; terrorist propaganda; and hatred against religious or ethnic minorities through social media, print media or any other electronic media. Even, any content over the internet or any other media that was deemed pornographic or otherwise inappropriate by the Government can be punished by fines or prison terms of various lengths under the Digital Security Act, 2018.

Since the independence of Bangladesh in 1971, the Government of Bangladesh has adopted laws in accordance with the demands and needs of the society as well as to prevent crimes and corruptions within the jurisdiction.

Digital Transaction Platform (IDTP)

The government is set to launch the Interoperable Digital Transaction Platform (IDTP) soon allowing people to move funds effortlessly within the financial sector such as banks, mobile financial service operators (MFSP) and payment service providers (PSPs) and at lower costs.

Recently, 09 (nine) members committee was formed for necessary amendment, incorporation, review, and reform of the Code of Criminal Procedure, 1898, aiming to make it a time-befitting and modernized one, and formulate it in Bangla.

Bangladesh Public Service Commission Act 2021



Draft Bangladesh Public Service Commission Act 2021 has found its initial approval, with the provision of up to 10 (ten) years in prison for leaking question papers, a minimum 03 (three) years in prison and financial penalties for leaking question papers of recruitment tests for government jobs administered by the Bangladesh Public Service Commission and Mobile courts will be

allowed to conduct drives and punish offenders during recruitment tests, up to 02 (two) years in prison or financial penalty or both for adopting unfair means during the tests, anyone obstructing the examinations to be held will get a year in jail, including the exam conductor if he/she is found guilty of irregularities, will get 02 (two) years in jail.


