

## NEW IMPORTANT LEGISLATIONS (OCTOBER 2022-DECEMBER 2022):

- Evidence (Amendment) Act, 2022; and
- International Centre for Diarrhoeal Disease Research, Bangladesh Act, 2022.



Competition law is a law that prohibits business institutions from engaging in activities that distort the competition in a market. The goal of competition law is to prevent businesses from participating in actions that undermine competition and the competitive process. By encouraging competition and reining in behaviors that can limit it, competition policy seeks to improve consumer welfare. Consumer prices decrease as a result of increased market competition, which also encourages the entry of new businesses, new investments, a wider range of higher-quality products, and more innovation.

The parliament of Bangladesh passed the much-anticipated Competition Act in 2012. The act consists of 7 Chapters and 46 sections. The key components of the Competition Act are as follows: In section 15 of the Act specific definitions of tie-in agreements, exclusive supply agreements, exclusive distribution agreements, refusal to deal agreements, and resale price maintenance agreements are discussed. Section 16 deals with the provisions in regard to abuse a dominant market position. Through section 21, combinations that may have a negative impact on market competition are forcibly forbidden. Section 17 & 18 deals with the Commission's preinquiry and inquiry processes.

The provisions of section 19 mention the Commission's authority to issue an interim order against anyone who disobeys section 21, subsections 15(1), 16(1), or any other provision that constitutes an offense under this Act. According to section 24, anyone who disobeys the Commission's directives without a valid excuse will face a sentence of up to one year in jail or a fine of up to one lakh taka for each day of disobedience.



According to the Competition Act, if found guilty, the Commission may impose a fine equal to triple the profit made from such anti-competitive action or 10% of their revenue over the previous three years, whichever is greater. To carry out the aforementioned objectives of the law, Section 5 of the Act mandates the creation of the Bangladesh Competition Commission (BCC). The BCC's goals are to eliminate anti-competitive market activities, foster and maintain competition, and safeguard trade freedom. In addition, the powers allow for the creation of rules, policies, notices, or administrative directives that are related to competition as well as the ability to advise and help the government in putting them into effect.

#### **CURRENT AFFAIRS**



The much awaited Dhaka metro rail was launched on Dec 28. However, in the first stage, the train will only cover a distance of 11.73 km from Uttara to Agargaon. It takes 20 minutes to complete the journey. The time will be 16–17 minutes once the train is fully functional. One coach per train has been reserved for women. But women are free to use other coaches as well. There are nine metro rail stations along the Uttara-Agargaon route. Metro stations have separate bathrooms for women passengers and special facilities for diaper changing. Seats are also be reserved inside coaches for pregnant women and elderly passengers. The train fare has been fixed at Tk 5 per km. The minimum fare is Tk 20.

#### **DID YOU KNOW**



Did you know that after pollution went out of control, the Bangladeshi Supreme Court granted every single river in the country legal rights to life. Now, the National River Conservation Commission has the right to sue anyone who causes any pollution river in Bangladesh.



A power of attorney and a foreign power of attorney are typically identical documents, but depending on the place, they are created differently. The Power of Attorney Act has really made it possible for those who live outside of Bangladesh to execute a Power of Attorney.

It is attested by an officer of the Bangladesh mission in that country and must be executed and signed by the holder within 60 days of arriving in Bangladesh. After that, it must be submitted to the Ministry of Foreign Affairs for its counter attestation and stamped within three months. In cases of registration of Power of Attorney, it shall be submitted to the sub-registry office within four months from the date on which it is received in Bangladesh.
